Subject: Hiding Corruption to avoid liability:

This COMMONWEALTH OF KENTUCKY, COUNTY OF SHELBY DIVISION, HEREINAFTER "COS" is hiding their aggressive tactics against The Yisra'el Nation from the Bench, the prosecutor's office and the Clerk's office together.

1: The prosecutor's office has to maintain that The Yisra'el Nation does not exist in order to manipulate the County Record that there exists a RESIDENTIAL BOND ONLY avoiding International securities fraud. If there is any aggression of self defense by The Yisra'el Nation to protect its free inhabitants, the prosecutor reports to HOMELAND SECURITY that there is a domestic terrorist group scaring and harassing the good and peaceful Public Officers of Shelby County and that Shelby County is in need of FBI and U.S. Marshall Assistance to quash these insurgents calling themselves The Yisra'el Nation. 4: The Bench has to appear that it is being very fair to the purported defendant with being forgiving with any failure to appear. The Bench knows all along that the Bond in question has already been forfeited to the Treasury for The Yisra'el Nation and assigned to International Incident Number-101220-000071. Meanwhile, make sure that the Sheriff's Office is watching out to see if the Secretary of State is driving anywhere within the Shelby County Body Politic. This includes Deputy Sheriff's slowing down and diligently looking into the car of the Secretary of State as it passes by. This type of harassment is designed to wear down the Secretary emotionally so that he will accept any possible alternative to being a part of another Independent State. Therefore, all treaty violations or kidnapping charges against the COS can be ignored and bypassed, relieving any Public Officer of Shelby County of any wrong doing and can go back to business as usual.

5: The prosecutor can cover up everything using the Sentinel News Paper to slander the Secretary of State once again, making fun of him and single him out as being a joke and all alone.
