Comes now, **Lanny Kay Talbot**, (hereinafter “*tort claimant*”) to petition the Human Rights Tribunal organized under Article 8, to issue a judgment and order of Human Rights Violations committed against the Universal Declaration of Human Rights agreed upon the 10th of December, 1948, and

JUDGMENT

Comes Now, a Judgment and Order by the Human Rights Tribunal,

WHEREAS, the tort claimant has claimed within the evidence submitted to this tribunal that UTAH HIGHWAY PATROLMAN SKYLER HARDWOOD, (hereinafter “*SKYLER H.*”), badge number 491 (hereinafter “*tortfeasor*”) is determined to be the tortfeasor, and

WHEREAS, in accordance with the evidence written in the affidavit by the tort claimant and filed with the Human Rights Tribunal that the tortfeasor’ did knowingly, intentionally and willfully commit human rights violations against the tort claimant, and

WHEREAS, the tort claimant has no intention of bringing suit before any Court of the City of Panguitch due to the fact that the City of Panguitch has deemed it necessary to hire 46 county deputies, 5 highway patrolmen, 3 city cops, 4 Forest Service Rangers, and 2 Fish and Game officers in a town of 1623 people. Therefore the City of Panguitch is the cause of the Human Rights Violations against the tort claimant for setting up a condition that is not cost effective to maintain and therefore sustainability is in grave danger of multiple Human Rights violations. The City of Panguitch has caused a condition that produces 60 dictators in a town of 1623 people, and

WHEREAS, the tort claimant claimed a Nationality within the Government of The United States of America on October 23rd, 2012, and as of date, the U.S. city-state, through its federal corporation has failed to correct its records when the Government of The United States of America has been very mindful of not trespassing on the U.S. city-state. The U.S. has blocked any attempt of the Government of The United States of America to receive country code while using a country code assigned to a corporation and not a country, thereby committing a fraud before the United Nations, and

WHEREAS, as a result, the tortfeasor’s are in violation of all thirty Articles of the Universal Declaration of Human Rights and all 4 books of the Law of Nations every day against each and every American National for the Government of The United States of America. Every day that goes by that the U.S. city-state does not correct its records is every day of more and more liability for the U.S. city-state in the form of Human Rights violations, and each and every law written in the Law of Nations, and

WHEREAS, The United States of America was in existence before the U.S. city-state and therefore any attacks upon The United States of America is an act of sedition and treason against one’s own country as a whole, and

WHEREAS, all of the U.S. city-states liability falls on the City of Panguitch for the actions of UTAH HIGHWAY PATROLMAN SKYLER HARDWOOD for not correcting its record that the tort claimant is a foreigner to the U.S. city-state, the City of London, and Vatican City and all U.S. city-states and therefore is not required to hold nor travel on any of its credentials. Further, the Government of The United States of America is more than capable of governing itself and is

with a permanent population with specific territory with the blessing of New Yerushalayim and the reign of the heavens, and

WHEREAS, the tortfeasor did knowingly, willfully and intentionally attempt to murder the tort claimant with the profile of domestic terrorist(*sovereign citizen*) in violation of Article 3 of the Universal Declaration of Human Rights, and

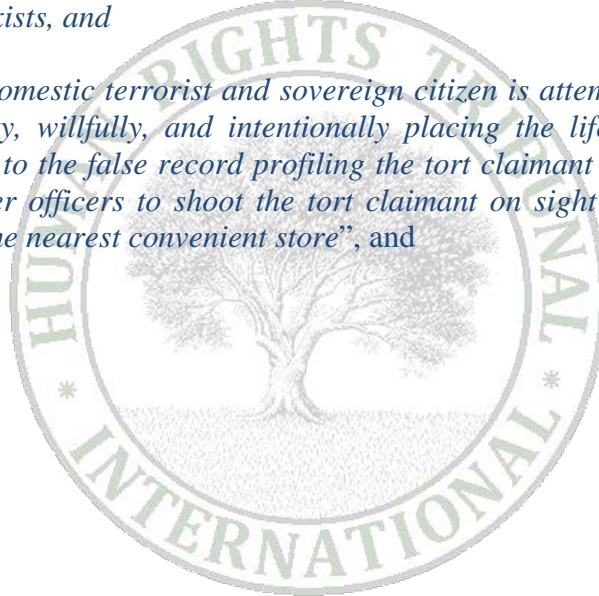
WHEREAS, the United States corporation has signed the following covenant:

5: -- [International Covenant on Economic, Social and Cultural Rights, Article 11](#)

"Everyone shall have the right to freedom of association All persons are equal before the law and are entitled without any discrimination to the equal protection of the law...."

Further, with a profile of sovereign citizen and domestic terrorist placed on the tort claimant, there is no possible way that the tort claimant would receive equal protection of the law when discrimination clearly exists, and

Further, the profile of domestic terrorist and sovereign citizen is attempted murder because the tortfeasor are knowingly, willfully, and intentionally placing the life of the tort claimant in danger indefinitely, due to the false record profiling the tort claimant as dangerous and violent which would cause other officers to shoot the tort claimant on sight if the tort claimant even asked for directions to the nearest convenient store", and

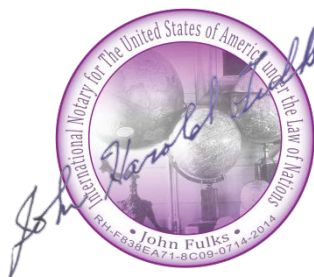


JUDGMENT

ORDER

BE IT ORDERED, that UTAH HIGHWAY PATROLMAN SKYLER HARDWOOD is hereby permanently suspended to cure violations of Articles 1 through 30 of the Universal Declaration of Human Rights and all four books of the Law of Nations, and

BE IT ORDERED, that the tortfeasor will cease and desist all contact with the tort claimant and claim against the tort claimant, directly or indirectly through others to let the tort claimant take care of the tort claimant's brother fulfilling the tort claimant's family obligations, and

BE IT ORDERED, that the U.S. record on all American Nationals is corrected to reflect that the American National is a foreigner to the U.S. city-state and is a part of an independent Government and country, and

BE IT ORDERED, that the U.S. record is cleared of any accusation or profile of domestic terrorist, sovereign citizen or any other harmful profile to cure the violation of Article 3 of the Universal Declaration of Human Rights, and

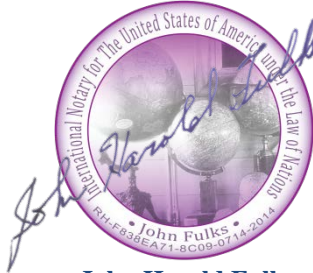
BE IT ORDERED, that a training program or class is provided to all officers required to attend to cure all violations of the Universal Declaration of Human Rights to avoid future violations and liabilities for risk management and the underwriters insuring any City, and

BE IT ORDERED, that any damages as a result of the unlawful detainment in the future shall be automatically rewarded to the tort claimant to cover expense and cost that may arise directly out of the tortfeasor actions and failure to act in a civilized manner, and

BE IT ORDERED, that the bonds and insurance of the tortfeasor are hereby suspended upon review of the training procedures and the state of mind of the tortfeasor in an effort to cure the totalitarian and superiority complex that the tortfeasor are currently suffering and displaying publicly thereby terrorizing the Public at Large, and
