During a House Foreign Affairs Committee hearing on Wednesday, Rep. Ilhan Omar (D-Minn.) fiercely grilled President Donald Trump's [Venezuela](#) envoy [Elliott Abrams](#) over his support for U.S.-backed massacres and genocide in Latin America throughout the 1980s, as well as his role in the Iran-Contra scandal... Rep. Ilhan Omar (D-MN) trivialized the deadliest terrorist attack in U.S. history in a recent speech she gave at an event for the Council on American-Islamic Relations (CAIR) — which the United Arab Emirates has designated as a terrorist organization. When speaking about the 9/11 terror attacks, which killed approximately 3,000 American citizens, Omar described the attacks as "some people did something."
