International Bill against the United States under the constitution of the United States of 1789 from the Government of The United States of America under the Articles of Confederation of 1781 as amended August 5th, 2015

The Government of The United States of America hereby issues this Bill against the United States in the amount of taxes that has accrued since the year seventeen hundred and eighty nine (1789), all current taxes and any future taxes upon dishonor of this International Bill (if any) for trespass against the National Government of The United States of America since the year seventeen hundred and eighty nine.

This Bill is issued in accordance with UNITED NATIONS CONVENTION ON INTERNATIONAL BILLS OF EXCHANGE AND INTERNATIONAL PROMISSORY NOTES.

Delegation of Authority of office:

- 1: Drawer: the office of the Treasury for the Government of The United States of America,
- 2: Drawee: United States headquartered on Manhattan Island.



3: Payee(s): The perpetual Union of seventeen hundred and eighty one (1781) started under the Articles of Association of seventeen hundred and seventeen four (1774) and the Government of The United States of America.

4: Holder of this Bill: The Government of The United States of America.

5: Place of Payment: Continental Public Bank located on the world wide web at:

6: Payment is to be made in silver specie, land, property, Military, or any other asset including but not limited to unencumbered honest services of the United States to the Government of The United States of America and the States of the Union including but not limited to interest at 10 percent per annum from the year of seventeen hundred and eighty nine.

Terms and Conditions:

1: This instrument is payable on demand 90 days from the date of this international instrument.

2: This International instrument is "negotiable*", *not transferable-, ·not to order·, pay only,

3: If the drawee refuses this International bill under non-acceptance, then this International Bill is authorized to convert itself into an International Lien against the drawee. Dishonor of first in time first in right is dishonourable in accordance with the Law of Nations and therefore the dishonor is lien able.

This International Instrument is hereby presented for tender of payment against the United States and is hereby payable and due within ninety days from the date of this instrument to the payee(s).
