THE ADMINISTRATIVE RECORD COVERS MANY ASPECTS OF THE LIVES OF PEOPLE.

EXAMPLES INCLUDE:

*STATUS, MARITAL STATUS, DEATH, LIVE BIRTH STATUS, EMPLOYMENT, ADDRESS, PHONE NUMBER, SSN, TAXPAYER, CITIZEN, NATIONAL, MILITARY SERVICE AND RANK, ETC.,*

# THE ADMINISTRATIVE RECORD

WHEN CORRUPTION OCCURS IN A **STATE OR NATION** GOVERNMENT, MANY PEOPLE DO NOT KNOW HOW TO FIX THE PROBLEM. THE REASON IS THAT THEY **DO NOT UNDERSTAND** THE ADMINISTRATIVE RECORD.

**CORRUPTION** MEANS:

**THE DELIBERATE MANIPULATION OF THE NATIONS ADMINISTRATIVE RECORD TO HIDE AN INDISCRETION OR CRIME.**

# THE ADMINISTRATIVE RECORD

FOR EXAMPLE:

**“A” WITNESSES A CRIME THAT HAS BEEN COMMITTED BY “B”.**

**“A” BRINGS THE INFORMATION TO “C” THAT IS ENTRUSTED WITH THE ADMINISTRATIVE RECORD.**

**“B” IS A VERY POWERFUL INFLUENCE ON “C” AND HAS THE ABILITY TO CHANGE THE ADMINISTRATIVE RECORD ENTRUSTED TO “C”.**

**“A” IS NOW ACCUSED OF THE CRIME COMMITTED BY “B” BASED ON THE ADMINISTRATIVE RECORD ENTRUSTED TO “C”.**

**“A” GOES TO JAIL FOR A CRIME COMMITTED BY “B”.**

# THE ADMINISTRATIVE RECORD

IN AMERICA, THE ADMINISTRATIVE RECORD IS ENTRUSTED TO A PRIVATE ASSOCIATION CALLED “**THE AMERICAN BAR ASSOCIATION**”.

THE ADMINISTRATIVE RECORD IS **NOT ENTRUSTED OR CONTROLLED BY ANY GOVERNMENT ENTITY** IN AMERICA.

IF THE ASSOCIATION HAS IDENTIFIED YOU AS A *TAXPAYER*, OR A *CITIZEN* OF THE U.S., THEN IT IS SO IDENTIFIED BY THE ADMINISTRATIVE RECORD.

THE SYSTEM WILL ACT IN ACCORDANCE TO THE ADMINISTRATIVE RECORD.

# THE ADMINISTRATIVE RECORD

## QUESTIONS:

**WHO ENTRUSTED A GOVERNMENT'S ADMINISTRATIVE RECORD TO A PRIVATE ASSOCIATION?**

**THE SOCIETY HAS NOTHING AGAINST THE PRIVATE ASSOCIATION.**

**THE SOCIETY MEMBERS DO NOT UNDERSTAND WHY A PEOPLE OF A PARTICULAR COUNTRY WOULD TRUST THEIR LIVES TO A PRIVATE ASSOCIATION RATHER THAN TO A GOVERNMENT, THEN BLAME A GOVERNMENT WHEN THEY ARE ABUSED BY POOR ADMINISTRATIVE PROCEDURES OF A PRIVATE ASSOCIATION **ENFORCED** WITHIN THE PRIVATE ASSOCIATIONS COURTS.**

**THE PRIVATE COURT EXISTS BECAUSE ITS EXISTENCE IS PLACED ON THE ADMINISTRATIVE RECORD AS A **STATE COURT** WHEN THE **PRIVATE COURT** WAS CREATED OUT OF THIN AIR.**

# THE ADMINISTRATIVE RECORD

IT IS ALWAYS BEST TO TAKE CONTROL OF YOUR OWN ADMINISTRATIVE RECORD OR USE YOUR RIGHT OF SELF DETERMINATION TO START YOUR OWN NATION AND ENTRUST THAT NATION WITH YOUR ADMINISTRATIVE RECORD.

THE ADMINISTRATIVE RECORD IS THE KEY TO **SLAVERY** OR **INDEPENDENCE**.

# THE ADMINISTRATIVE RECORD

the **definition** of a *sovereign entity* is:

“one that has the authority by being entrusted with the administrative record of its people.

RIGHT NOW THOSE ENTITIES ARE,  
**The United States of America** and the  
**reign of the heavens for the American Nationals.”**



# THE ADMINISTRATIVE RECORD

THIS IS THE REASON BEHIND THE DECLARATION OF EXILE, PROCLAMATION AND THE AFFIRMATION.

EXILE FROM THE PREVIOUS ADMINISTRATIVE RECORD, PROCLAIM THE EXISTENCE OF A NEW ADMINISTRATIVE RECORD HOLDER, AND SEAL THE AGREEMENT WITH AN OATH OR AFFIRMATION.

OATHS AND AFFIRMATIONS HAVE VALUE, SO THERE IS CONSIDERATION FOR THE CONTRACT.

IF THE PREVIOUS ADMINISTRATIVE RECORD HOLDER DOES NOT RELEASE YOUR ADMINISTRATIVE RECORD TO THE NEW ENTITY, AND PROCEEDS TO RE-DEFINE YOU AS A SOVEREIGN CITIZEN/DOMESTIC TERRORIST ON THE EXILED ADMINISTRATIVE RECORD, THAT IS *ATTEMPTED MURDER*, COULD BE *MURDER* AND *CONSPIRACY TO COMMIT MURDER* OF A NATIONAL OF A FOREIGN SOVEREIGN ENTITY.

# THE ADMINISTRATIVE RECORD

THE VERY FACT THAT THE EXILED ADMINISTRATIVE RECORD HAS REFLECTED THAT SCENARIO IN THE PREVIOUS SLIDE IN AMERICA, JUSTIFIES THE EXILE, PROCLAMATION AND AFFIRMATION OF THE CURRENT **American Nationals.**

# THE ADMINISTRATIVE RECORD

## ON THE ISSUE OF THE STATE OF NEVADA RUNNING AN INDEPENDENT STATE

If the people would follow protocol, they would have declared exile from **the United States inc.**

Proclaimed the existence of the **State of Nevada** as an *Independent State*.

## THE TRUE ADMINISTRATIVE RECORD OATH OF THE ORIGINAL STATE OF PENNSYLVANIA IN 1778

*We whose names are hereunto Subscribed Do solemnly and sincerely Declare and Swear, (or affirm,) That the State of Pensilvania is and of right ought to be a free Sovereign and Independent State—and I do forever renounce all Allegianec, Subjection and Obedience to the King or Crown of Great Britain, and I do further swear (or solemnly, sincerely and truly declare and affirm) that I never have since the declaration of Independencie, directly or Indirectly aided, assisted, abetted or in any wise countenanced the King of Great Britain, his Generals, fleets or armies; or their adherents in their claims upon these United States, and that I have ever since the declaration of the Independencie thereof demeaned myself as a faithfull citizen and subject of this or some one of the United States, and that I will at all times maintain and support the freedom, sovereignty and Independencie thereof.*
