MINUTES OF THE MEETING

On the 24th day of **September** in the year **2014**, at **10:30** PM Central. The Ministers for the reign of the heavens society convened a meeting, identified as: **20140924-RHS-MMIN**. The Ministry of Finance, Ministry of Foreign Affairs, Ministry of Governance, and Ministry of Trusts were present.

BE IT RESOLVED, that a motion was entered therein to render a vote of "no confidence" in the Social Security Administration of the United States to administer Social Security under **Article 22** of the **Universal Declaration of Human Rights** for some of the following reasons:

- 1: Identity theft, and
- 2: Social Security is being used as a weapon of war against the people that are entitled to Social Security under **Article 22** of the **Universal Declaration of Human Rights**, and
- 3: The Social Security number is being used as an identification number brand, in the nature of branding an animal and in the nature of a tattoo being placed on the arm of an individual much like the Nazis did during WWII instead of a private savings account number for retirement, and
- 4: The Social Security number is now being required to be able to pay for the most basic essentials and services to sustain life in "violation of Title 5, section 552a of the United States Code under its Privacy Act of 1974", further, the original intent of the Social Security number and other personal identification numbers such as a driver's license is to be used for the following benefits:
 - A: to receive public assistance benefits, and
 - B: to pay Social Security taxes, and
 - C: to receive Social Security payments and refunds, and not to be used as a brand to investigate whether someone is a terrorist, credit checks, court cases, bank accounts, jurisdiction device, nor determine an individual's status, and

BE IT RESOLVED, that a motion was heard to give the treasury for The United States of America a vote of confidence to take over administering Social Security under **Article 22** of the **Universal Declaration of Human Rights** for affirmed American Nationals, if they so choose independently of each other through a "no confidence" form provided by the assembly for the Government of The United States of America, the motion was seconded, and there were no objections, and

BE IT RESOLVED, that the current administration of social security by the Social Security Administration of the United States has distorted the original intent of **Article 22** of the **Universal Declaration of Human Rights**, distorted into something vile and threatening instead of its original intent of peace and security, and

BE IT RESOLVED, that dignity and free development of one's personality can only be obtained in a peaceful environment which has not been sustained due to the petro dollar wars currently taking place in the world, and

BE IT RESOLVED, that the meeting for the reign of the heavens society adjourned on the 24th day of **September** in the year **2014**, at **11:00 PM** Central to re-convene at a future date certain.
