ADOPTION OF THE UNIFORM COMMERCIAL CODE

ADOPTION

The committee, convened under Article VI of the Articles of Confederation as amended May 20th, 2013, hereby adopts the Uniform Commercial Code, and

PURPOSE

The Code, as the product of private organizations, is not itself the law, but only a recommendation of the laws that should be adopted in the states. Once enacted by a state, the UCC is codified into the state's code of statutes. A state may adopt the UCC verbatim as written by ALI and NCCUSL, or a state may adopt the UCC with specific changes. Unless such changes are minor, they can seriously obstruct the Code's express objective of promoting uniformity of law among the various states. Thus persons doing business in different states must check local law. The Government of The United States of America wishes to do business with the various states and therefore it is necessary to adopt the Uniform Commercial Code to have a uniform reciprocity with the states wishing to do business with the Government of The United States of America and its Nationals, and

IMPLEMENTATION OF THE UNIFORM COMMERCIAL CODE

Upon this act of adoption by the committee for the Government of The United States of America, the committee shall have and hold the Uniform Commercial Code (UCC) for the purpose of using the code when necessary within each of the Departments of the Government, and

Further, the UCC will be available for the assembly while enacting certain statutes for the purpose of self governance of the American Nationals while involved in foreign trade with the various states and other countries, and

UNIFORMITY WITH THE UNIVERSAL DECLARATION OF HUMAN RIGHTS

Each statute enacted by the assembly must pass the test of the Universal Declaration of Human Rights to ensure that each American National may not fall into a third world country condition of violence and chaos, and

ASSIGNMENT

The committee hereby assigns the Uniform Commercial Code in its entirety or in sections as needed to the Department of Transportation within the Government of The United States of America and the International Public Bank that the committee governs. The committee reserves the right to make assignments when needed to serve the interests of the American Nationals, and

SETTLEMENT OF DISPUTES

The General Post Master Council convened is hereby assigned the authority to settle any disputes involving the UCC and its implementation into statutes by the assembly for the Government of The United States of America, and

PROCESS OF SETTLEMENT

- 1: The committee assigns the UCC to a particular Department of the Government of The United States of America, and
- 2: The Department implements all or part of the UCC in the daily business of the Department while serving the American Nationals under "Department rules of operation", and
- 3: If a conflict arises, the conflict is resolved by the General Post Master Council, and
- 4: The case is sent to the assembly and the assembly writes the statute to maintain the settlement of the General Post Master Council under the "IT IS FORBIDDEN DOCTRINE" and therefore enforced by the Human Rights Defenders in accordance with the statute, and

IT IS ADOPTED, by the committee on the 29th day of May, 2015,
