BE IT RESOLVED, that a motion was passed to declare the National Basketball Association (NBA) traitors; and

BE IT RESOLVED, that a motion was passed to classify the Me Too Movement (#MeToo) as connected to world communism, fascism, and Marxism; and

FURTHER BE IT RESOLVED, the Me Too Movement (#MeToo) is operating and doing business as revolutionary militants within the metes and bounds and seaward boundaries of the Government of The United States of America attacking civilians; and

BE IT RESOLVED, that a motion was passed to transfer the [Bryan Parker](#) and [William David Parker](#) WAR CRIMES TRIBUNAL case to the American National Union of The United States of America; and

BE IT RESOLVED, that a motion was passed to accept and acknowledge hearing the torture charges in the [Graham Bradford Lascsak, Trustee case](#); and

BE IT RESOLVED, that a motion was passed to declare all major News Media outlets and News Networks as revolutionary militants with daily attacks against civilians with communist propoganda; and

BE IT RESOLVED, that a motion was passed to recognize the Red Flag Law as an extension of the Me Too Movement (#MeToo); and

BE IT RESOLVED, that a motion was passed to hold Anna Maria Riezinger, Paul Stramer and James Belcher in contempt of Human Rights violations; and



BE IT RESOLVED, there were no objections that the office of the registrar for the Government of The United States of America transfer all State resident Declarations received by the Government of The United States of America to the Secretary for the American National Union of The United States of America to be used only for communication and not for sale or personal business; and
