**BE IT RESOLVED**, that a motion was passed to classify the LGBTQ movement as a mental illness; and

**BE IT RESOLVED**, that a motion was passed to recognize DIVERSITY as a violation of the Universal Declaration of Human Rights; and

**BE IT RESOLVED**, that a motion was passed to hereby adopt the **Lee Resolution** and bring it forward to the present time; and

**FURTHER BE IT RESOLVED**, that the Lee Resolution will be enforced by the Government of The United States of America; and

**BE IT RESOLVED**, that a motion was passed to charge Democrats and Republicans with exercising subversive activity; and

**BE IT RESOLVED**, that a motion was passed to object and condemn the **Convention on the Rights of the Child**; and

**BE IT RESOLVED**, that a motion was passed that the Fraternal Order of Police (FOP) and all other police unions are to be replaced with militias due to subversive activity; and

**BE IT RESOLVED**, that a motion to notice any and all electric companies, water companies and all other energy fuel sources that if found to be turning electricity off or used as a list of people that are a member of a subversive Totalitarian Party for the purpose of subversive political activity or a war of attrition is a formal declaration of war against the inhabitants, residents and Americans and will be executed or exiled within 3 days of said act of subversion; and



**FURTHER BE IT RESOLVED**, that if any and all energy sources are used to manipulate anyone at any time is considered subversive activity; and

The National assembly having addressed all other motions and resolutions on the agenda file name 20191209 Agenda for the National assembly; and

**BE IT RESOLVED**, the meeting for the National assembly adjourned on the **265<sup>th</sup> day, in the year of Yahweh, six thousand and twenty one, translation 9<sup>th</sup> day of December, two thousand and nineteen, at 8:40 Universal Time -6** to re-convene at a future date certain.
