The Totalitarian Party within the United States, or any other variation thereof (hereinafter "respondents") declared through third party website forum known as Infowars respondents proclamation to the world of the political declaration towards communism, and

Private companies cannot be political parties although private companies can lend to political activity and therefore both Democratic and Republican Parties are one political party herein defined as the Totalitarian Party. Respondents are violating Natural Law with interfering with the right of self determination for all the inhabitants within the metes and bounds and seaward boundaries of The United States of America by forced opposition towards perpetual exile through declaring communism within the Country, and

Respondents use manipulative tactics of the owners of Infowars without the knowledge of the owners of Infowars reporting as alternative news was respondents publication of intent to falsify the international record to the world respondents proclamation that communism is the declared form of political ideology within the metes and bounds and seaward boundaries of The United States of America. There is no legal existence of a US created chartered town, city, or county in which the States have ceded the public property to and wherein these aforesaid US created corporate home-rule charters operate under the 527 organizations declared as the Communist Party and the votes for the elections are regulated through the aforementioned US created corporate home rule charters, and

Respondents used the third party website forum infowars where the owners of infowars reported with the story title styled as "Dems Choosing Communism, Globalism Over America"; as reporting alternative news is reporting in opposition to mainstream media news wherein the alternative news is manipulated to unknowingly allow the alternative news website Infowars as the platform for the declaration of communism by respondents; wherein respondents are attempting to falsify the international record through continuous attack tactics through mainstream media news sources which are fake news and with intent of a coup to remove the current CEO of the United States private company and commander in chief of the United States Military Donald Trump, and

Respondents uses forced opposition to the genius form of republic government being that a republic voted through democracy in bilateral social compact agreement for a declaration of obligations and rights is a issue to the illegal profits and incentives of a communist capitalist system based economy, will lose control and power and the declaration by respondents through third party website forum Infowars was a notice to the public for future attempts of private property theft which violates the Laws of Armed Conflict as a military occupation attacking civilians and separating families, all 30 articles of the Universal Declaration of Human Rights, the Law of Nations and Natural Law for violating the intangible rights between people and tangible private property rights, and

From the third party website Infowars with the aforementioned styled title, a snippet from the broadcast showed a news anchor from a mainstream media source wherein the news anchor said that the respondents are consorting with global leaders and are in opposition of the current CEO of the United States private company and commander in chief of the United States Military Donald Trump; for not being influenced by world Communist Party global leaders to which the news anchor on the snippet from the aforesaid broadcast stated respondents are "harbinger" to the global leaders which has been why the mainstream media have been in opposition to the current CEO of the United States private company and commander in chief of the United States Military Donald Trump, and

The respondents attempted to sneak in the aforesaid declaration of communism in the third party website forum Infowars without the owners of the infowars awareness that reporting the aforementioned subject matter story styled title was the declaration of communism and was a discreet in the back door public international notice to proclaim a communist country and without any disclosure to any bilateral social compact agreement with the inhabitants within the metes and bounds and seaward boundaries of The United States of America; which violates Natural Law in the sense that it imposes forced association, and
