JUDGMENT

Comes now, a Judgment and Order from **the Human Rights Tribunal International**,

WHEREAS, the tort Claimant has claimed within the evidence submitted to this tribunal and Published for over 50 days in the newspaper that the Respondents has and continues to commit violations against the Universal Declaration of Human Rights.

WHEREAS, the Respondents have failed to appear before this court for the Hearing date of 177th Day in the Year of Yahweh 6022 and a translation date of September 11, 2020 hence forth a summary judgement has been awarded to the Claimant against The American States Assembly and Anna Von Reitz as the inciting party.

The evidence, proof and intent declared, demonstrates that the leader Anna Von Reitz and the Coordinators conspire through their actions of theft, wordings, workings, challenges to property without demonstration of title, theft of intellectual property, and the attempted theft of the metes and bounds and seaward bounds of a truly free people. WHEREAS, demands, statements of declaration and public notices to the effect that “we own you” need no other proof of the Respondents blatant institution of Slavery and Slavery Claims upon all Unions, Inhabitants, Americans, American Nationals, General Postmasters, Government Office holders of The United States of America, and any other foreign parties residing in America for other Governmental Businesses or Non-Governmental Organizations. This is a clear statement of Slavery by Respondents which is unacceptable to many people groups world-wide and the Universal Declaration of Human Rights. This clear violation of Slavery therefore strips all Respondents of their rights of immunity.

WHEREAS, Respondents believe it possible to steal the metes and bounds and seaward boundaries of a sovereign nation and then declare that they are exempt or immune to any recourse or prosecution. This is an attempt to steal/usurp and be found innocent.

It is therefore the Human Rights Tribunal International Judgment that the Respondents are guilty of all thirty articles of the Universal Declaration of Human Rights according to the evidence of Slavery.

Further, the Respondents have assumed a false leadership role to decree things that are not true as though they are true. This has further complicated the existence of a free sovereign



people in social compact and living in peace with each other as the Respondents have attempted to attach instruments of ownership by other identified parties known here as “Fiduciary”, “States Assembly”, and “Power of Attorney”.

Further, to complicate matters a particular Anna Von Reitz in leadership has also sworn a blood oath to the Pope of the Catholic Church and Sovereign City State as its Monarch and also the Jesuit Society. JUDGMENT

NOW THEREFORE:

BE IT JUDGED, that the claims brought to the Human Rights Tribunal International gives witness to the existence of violations of all 30 Articles of the Universal Declaration of Human Rights, further, the main charges of Slavery and theft of the metes and bounds and seaward boundaries by Respondent's own declaration of fact. ORDERS

BE IT ORDERED, that Respondents, are under arrest for the 30 Human Rights Violations against the Universal Declaration of Human Rights, and under international law, thereby giving jurisdiction on the local, state, federal and International level in this particular case in accordance with international law if it so chooses to intervene, and

FURTHER BE IT ORDERED, that all sovereignty, freedoms, liberties, rights, privileges, immunities, reputation in good standing, Nationality, and peace is hereby upheld to the Claimant, and

FURTHER BE IT ORDERED, that a particular Respondent, named, Anna Von Reitz, is here and now ordered to be immediately seized and put in prison for a term of no less than 37 years, and

FURTHER BE IT ORDERED, that this judgement and any further evidence of violations of the UDHR or any other deprivation of character will be sent to the Law Department for the Government of The United States of America and the War Crimes Tribunal for review for possible crimes against humanity under international law, and

FURTHER BE IT ORDERED, that no retaliation or harassment against the American National Union and the Government of The United States of America, its office holders, or any other American National shall be tolerated, any retaliation by anyone shall be resisted with automatic

arrest of the Human Rights Violator and tried in this Human Rights Tribunal immediately upon a proper affidavit and evidence to support the violation, and

FURTHER BE IT ORDERED, that any articles on the internet that attempt to distort the history of the American National Union, The United States of America, the Government of The United States of America, and the American Nationals thereof, is an attempt to interfere with the Social Compact Agreement of its people and is an act of terrorism against The United States of America and in violation of the UDHR, and

FURTHER BE IT ORDERED, that the Law Department for the Government of The United States of America reserves the right to utilize this Judgment and Order and any and all evidence herein any future charges or court actions in this or other court of Law.

FURTHER BE IT ORDERED, that this Judgment and Order be sent to The office of the Treasury for The United States of America, Global Postal Code: NAC: 850H2 MR7C8-0007, The United States of America For the purpose of attaching a fine as requested by prosecution for monetary damages and jail time associated with Violations of all 30 Articles of the Universal Declaration of Human Rights.

FURTHER BE IT ORDERED UNDER GENERAL ORDER: that any and all Foreign Monarchs, Governments, incorporated and/or unincorporated Associations, Agencies or agents thereof are hereby ordered to cease and desist any and all interference or disruptive actions towards The United States of America, the American National Union of The United States of America, the Government of The United States of America, American Nationals, the Social Compact Agreement of its Nationals, the power of attorney, its Law form, and freedoms thereto, and
