BE IT RESOLVED, that a motion was passed to request that the assembly recognize that human life begins at the spark of life, which consists of two (2) living cells known as sperm and egg; and

The National assembly having addressed all other motions and resolutions on the agenda file name 20200921 Agenda for the National assembly; and

BE IT RESOLVED, the meeting for the National assembly adjourned on this 187th day in the year of Yahweh, six thousand and twenty two, and the 21st day of September two thousand and twentieth year of the new covenant in Yahushua's name, **at 10:00 Universal Time -6** to re-convene at a future date certain.
